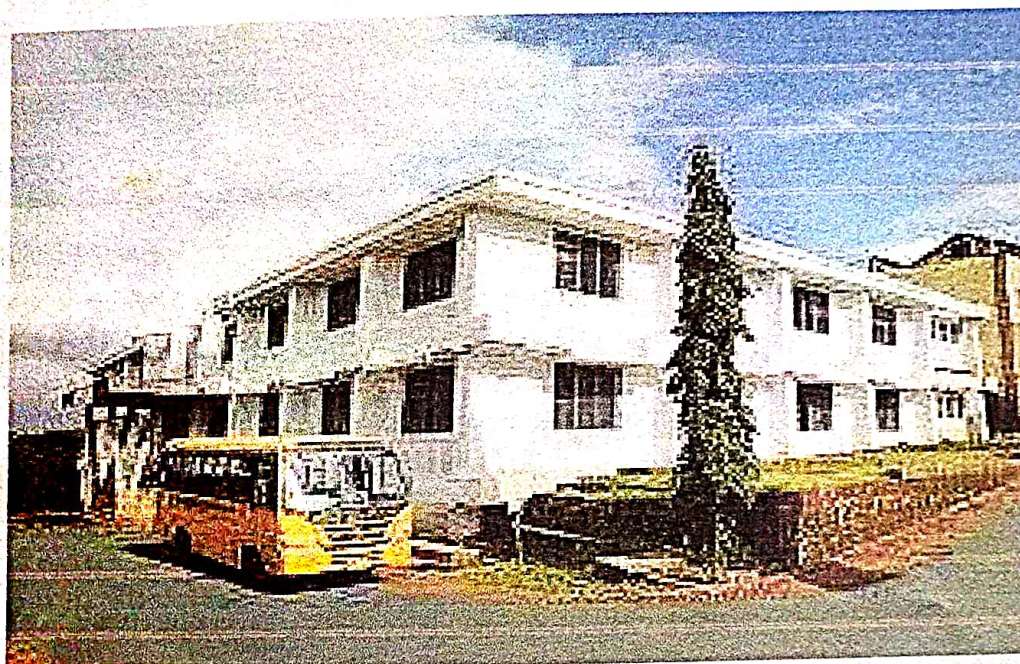
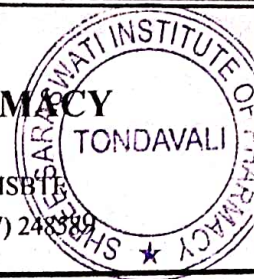

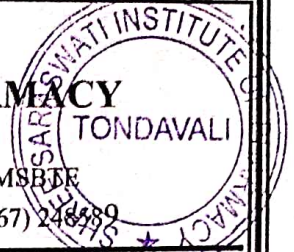

REPORT ON STUDENTS PARTICIPATION IN INTER COLLEGE COMPETITION

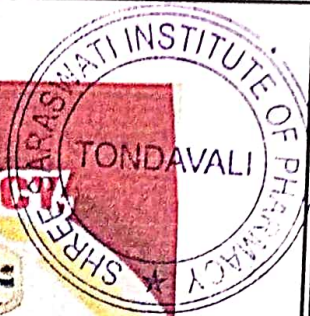
Our Institute always encourage students for participation in various intercollege competitions. Students of our institute enthusiastically participates in various intercollege competitions.

Vijayrao Naik College of Pharmacy held a SANSKRITI-2024: A Techno- Cultural Fest, an intercollege competition on 29th February 2024. It was overwhelming to see that our institute students participated in this fest. The event included four competitions, poster presentation, oral presentation, quiz, solo Singing and Group Dance. The schedule of the program was planned such that the four competitions were organized in parallel sessions in separate place. The morning session began with registrations for the respective events which included poster and oral presentation.

10 students from our institute were participated for the poster presentation and 5 students for oral presentation. 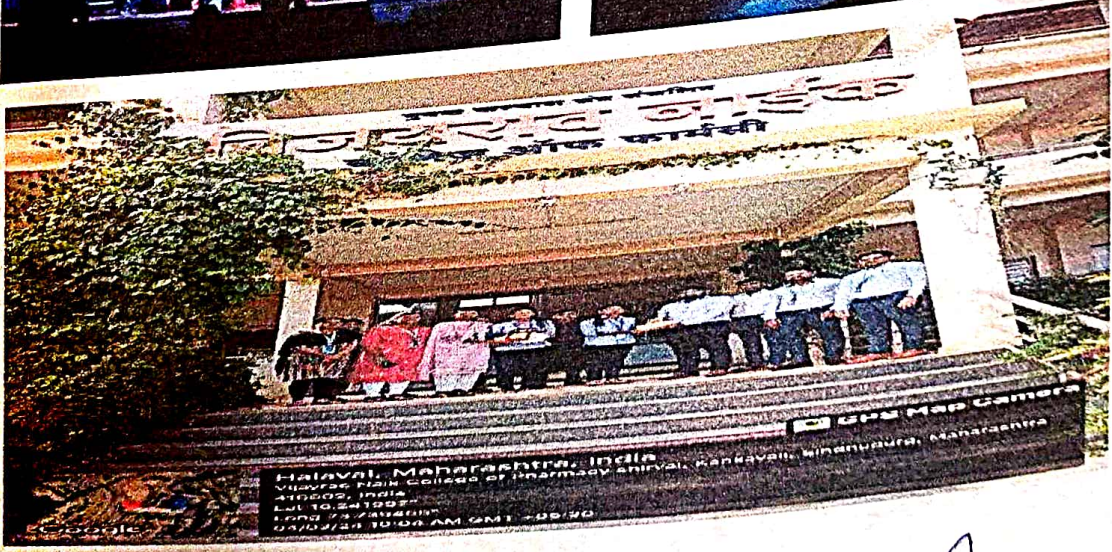
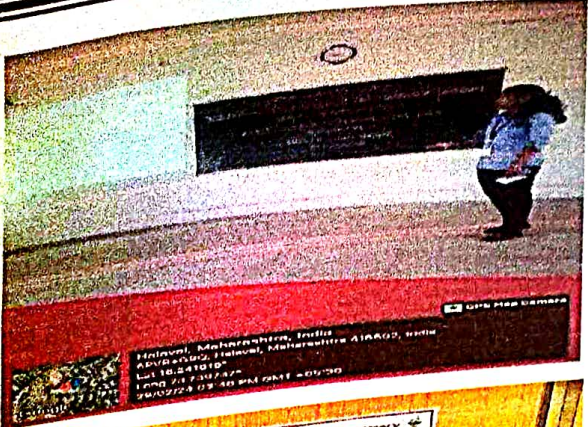
